

Financial institutions and financial institution groups are expected to adapt their governance and the scope and nature of their services to respond to these changes. Many different types of entities may be referred to as a "financial institution"—including, for example, major banks, trust banks, overseas banks, online banks, small- and medium-sized and regional financial institutions, and government-managed financial institutions—but each type has its own unique challenges.

In providing financial institutions with legal services, we ascertain the nature of each institution's financial business, based on the environment in which it conducts its operations, and the category of its business, to advise on the issues facing that institution.

Many of our attorneys who are engaged in these matters have been seconded to the Financial Services Agency or other regulatory agencies in the past, and are intimately familiar with the current approaches of those regulatory agencies.

Our attorneys provide sophisticated legal services by combining their knowledge in infrastructure- and energy-related project finance and their knowledge in general Banking and Finance transactions.


